Property Crimes Section at the US Attorney's Office for the Central District of California, where he "focused on criminal activity arising out of the Asia-Pacific region," according to the publication.

Cheng, who began his career as an O'Melveny associate in the 1990s, returned to the Firm in June 2015 as a partner in the White Collar Defense and Corporate Investigations Practice. He resides in the Firm's Los Angeles and Hong Kong offices.
