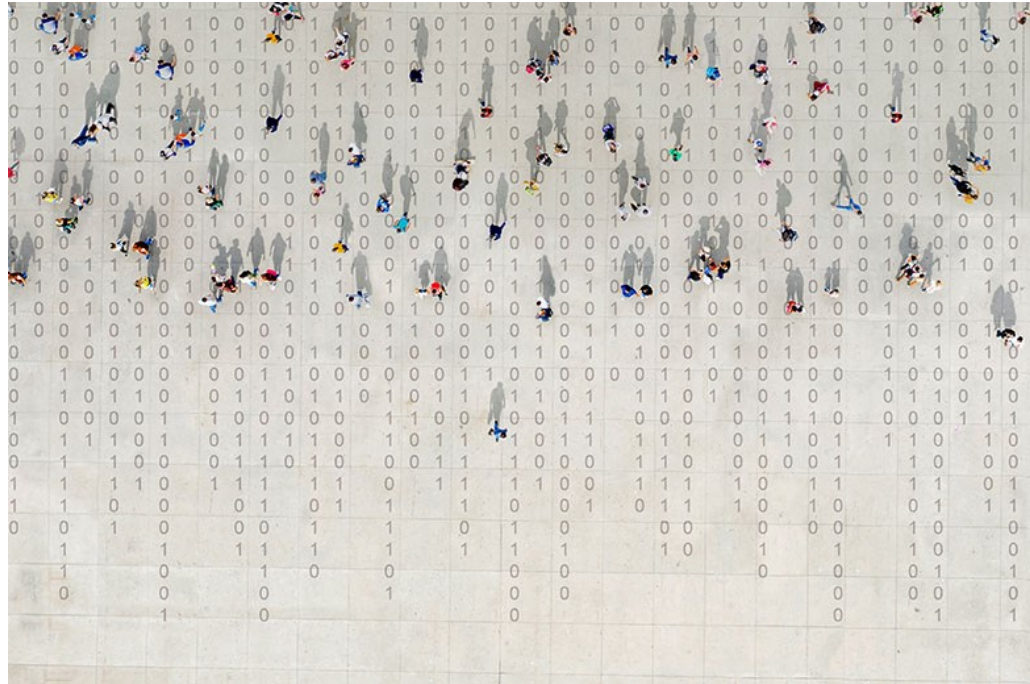

Overview

The California Consumer Privacy Act (CCPA) is the State of California's new data privacy law imposing significant obligations on companies with respect to the personal information of California residents.

The CCPA took effect on January 1, 2020, with enforcement beginning on July 1, 2020. Enforcement is expected to be vigorous, with the California Attorney General making several public statements that his office will actively enforce the law. In addition, civil litigants have already filed class actions seeking statutory damages under the CCPA for security breaches.
