### Litigation

#### American Airlines

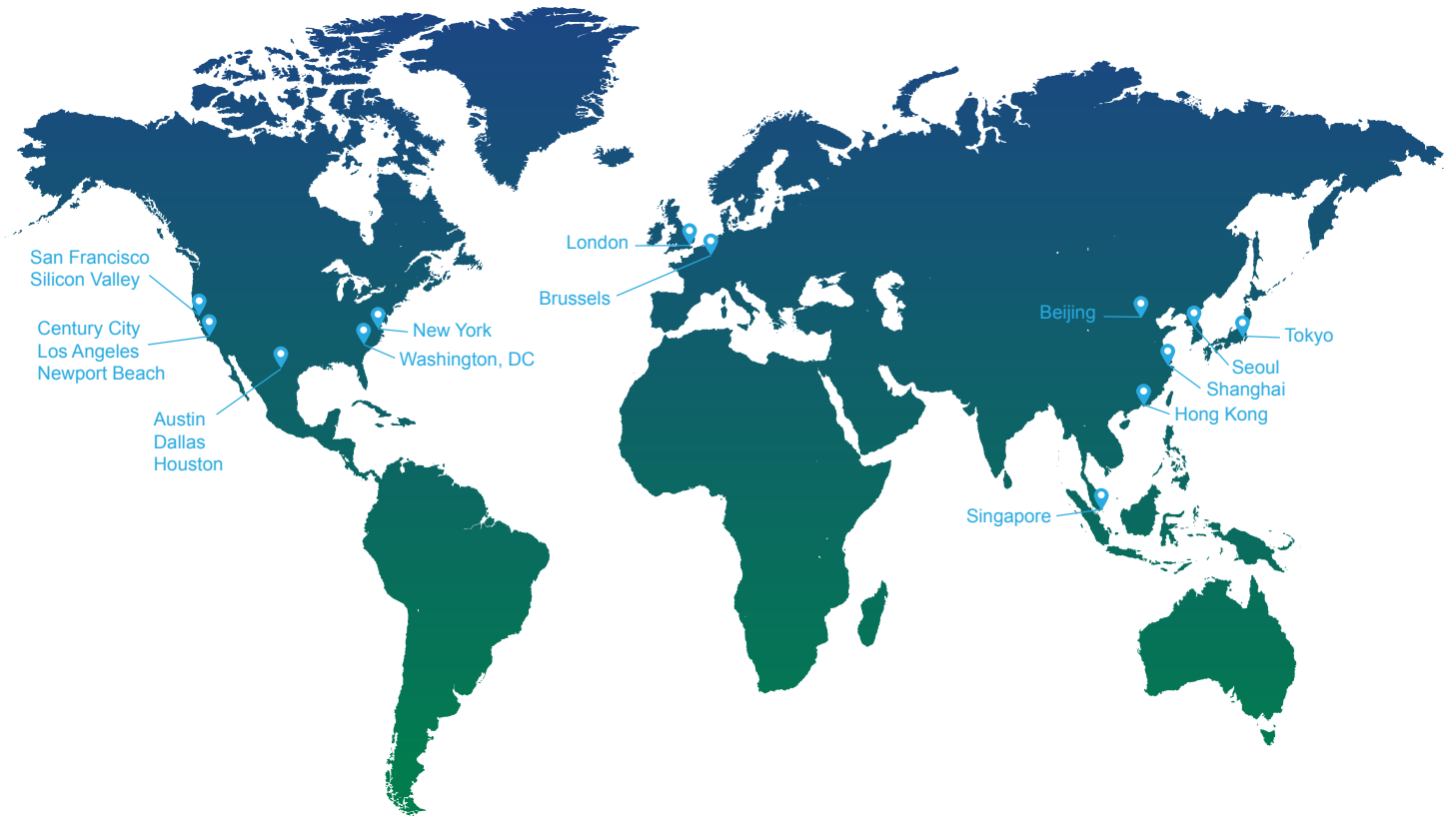
